- 9.6 Without prejudice to our other rights under these terms and conditions, if you breach any provision of these terms and conditions in any way, or if we reasonably suspect that you have breached these terms and conditions in any way, we may delete, unpublish or edit any or all of your content.
- 9.7 You warrant that you are the intellectual owner of your material and that there are no plagiarised or inappropriate parts of the material;
- 9.8 You agree that you bear sole responsibility for violations of copyright and intellectual property infringement that may be contained in your material;
- 10. Rules about your content
- 10.1 You warrant and represent that your content will comply with these terms and conditions.
- 10.2 Your content must not be illegal or unlawful, must not infringe any person's legal rights, and must not be capable of giving rise to legal action against any person (in each case in any jurisdiction and under any applicable law).
- 10.3 Your content, and the use of your content by us in accordance with these terms and conditions, must not:
